WHEREAS, two (2) sealed proposals were received, opened, and read in public on May 19, 2015 at 3:30 p.m. prevailing time for Fabricated and Prefabricated Structures: Portable Sanitation Units, Contract No. PCC-0029-15; and

WHEREAS, the bid as submitted by Mercer Group International, 1519 Calhoun Street, Trenton, NJ 08638 was reviewed by the Deputy Director of Maintenance and it was determined that it meets the specifications.

NOW, THEREFORE, BE IT RESOLVED by the Somerset County Park Commission that the award of contract for Fabricated and Prefabricated Structures: Portable Sanitation Units be made to Mercer Group International, 1519 Calhoun Street, Trenton, NJ 08638 and that the Purchasing Agent is hereby authorized to issue a purchase order to the said vendors.
