

**SOMERSET COUNTY PARK COMMISSION  
RESOLUTION AWARDING THE SECOND AND FINAL YEAR OF A  
TWO-YEAR CONTRACT  
FOR ANIMAL FEED & SUPPLEMENTS  
CONTRACT PCC-0003-18**

**WHEREAS**, the Treasurer of the Somerset County Park Commission has certified in writing the availability of funds for the purposes set forth in this resolution, such certification being attached hereto and made part of hereof, and such funds are provided for in the duly adopted operating budget of the Somerset County Park Commission : \$15,318.00 (31-201-20-853-402-579); and

**WHEREAS**, the Somerset County Park Commission did originally open and review bids for Animal Feed & Supplements Contract PCC-0003-18 (hereinafter, the "Contract") on October 2, 2018; and

**WHEREAS**, Frank Carrajat dba Middle Valley Farms, 204 Schooleys Mountain Road, Long Valley, New Jersey 07853 for Option A, and Bohonyi Corporation dba Animals & Gardens Unlimited, 14 Jacobstown Road, New Egypt, New Jersey 08533 for Options B and C (hereinafter, the "Vendor") was awarded the first year of the Contract, by Park Commission resolution R18-241 on October 18, 2018; and

**WHEREAS**, the services of the Vendor have met the requirements of the specification in an efficient and quality manner during the previous year(s) of the Contract, thus, it is therefore recommended that the second and final year of the Contract be awarded to the Vendor for: Animal Feed & Supplements as follows:
